a. Public Safety

- i. Last week's small meet and greet with the officers. Officers shared some challenges they are facing and introduced a few of the beat officers who will respond to homes if there are issues.

b. Beautification

- i. Code Enforcement Jason Murphy
 - 1. Jason has been in constant communication with Officer Muckle, who is assigned to our area.
 - 2. Found some big cases on Peeples.
 - 3. Partnering with Toby Reinhardt of Keep SWATS Beautiful. He is here at our meeting and will join as well.

- ii. Neighborhood Clean Up Carissa Zedaker
 - 1. March 13 and March 27, April 10 and April 24 all from 10 noon
 - 2. Meet at James Orange Park until Carissa chooses the pick up locations.
 - 3. Carissa has reached out to Keep Atlanta Beautiful and Keep SWATS Clean. Rogelio Arcelis has also been doing cleanups. He can also speak at the end to partnership.

c. Historic Preservation

- i. Chika is working to get a handle on the active construction.
- ii. Primary focus is investor owned.
- iii. City has done two sweeps for Historic Oakland City, and will do another before March 1.
- iv. Geno Yoscovits asks if there are standards he can adhere to as he rebuilds his house. Check out occoatl.org/historic
- v. James Keon asks about a specific violation. Advised to take offline with Chika.
 - 1. Chika quickly addressed stop work placed. Court date in March. Starting to take actions to remove the paint.
- vi. Elijah is interested in joining Chika's committee.

d. Zoning

- i. Great meeting last week. A few updates:
 - 1. Made recommendation to delay the NPU vote on master plan subarea so that OCCO can comment. Missing spur trails originally envisioned, side walks, etc. Having dedicated meeting.
 - a. BeltLine Sub Area 1 Master Plan Neighborhood Revisions Meeting – March 3 at 6:30 p.m. on Zoom
 - 2. Atlanta Land Trust 27 homes proposed for Tucker Ave. UDC approved last week. They recommended that they add gables to all of the fronting town homes. They also made recommendations on siding etc to align with historic guidelines.
 - 3. Fort Mac board meeting last week Not a whole lot happened. They had a board resignation so haven't been meeting because didn't have quorum. They did report on building where FDA will

be moving into. Delayed because of COVID-19. LRA did made a \$70K sale for street light improvements at Tyler Perry Way/Lee Street and the entrance to Fort Mac. Georgia Power is buying very small portion of land to hold the light, versus light going across the street. LRA board felt that it was lucrative enough to move forward with.

- 4. Lee + White Attended sub-committee meeting last week. New office spaces, food hall will be built.
- 5. Murphy's Crossing is pursuing either 501c3 or CDC. Putting funds from developer into fund to benefit the neighborhood.
- 6. Dr. Minor asks: is there a displacement fund? Kyle said he will send information out from what the BeltLine shared.
 - a. Kyle says that Dr. Minor has been instrumental in this.
 - b. City of Atlanta also says they are exploring antidisplacement funds.
 - c. Kyle will keep the neighborhood informed.
 - d. Kyle to send out BeltLine anti-displacement fund information.

e. Gardens & Trees

- i. Free Ivy Removal for Neighbors
 - 1. Saved 38 trees last weekend!
 - 2. Volunteering every weekend through the end of March, at least.
