- Lee street to Donnelly and Cambellton
- Why rezone?
 - Atlanta is growing fast!
 - Want to grow in an orderly fashion
 - Improve resident quality of life
- Current use:
 - o Flea market will become an event space
 - Lee street is currently
 - C-2 Commercial -
 - I1 Light commercial -
 - Recommend to switch to MRC Zoning mixed residential commercial
- Resident concern:
 - Want better sidewalks or buses to MARTA for those with limited mobility
- Note: We are planning for 20 years down the road
- We are in phase 2 of the City rezoning topics
